All weekend rentals require a 50% deposit to reserve. Final payment is due before due date, if not paid, delivery will not be made.

Johnny Blue Inc. also trading as Executive Bathrooms Plus LLC cannot be held liable for any electrical issues that occur to your equipment. Electric should be as close to the unit as possible, no more than 100 Feet. Generator is available for rent, if needed. Charge is \$150.00 due before delivery.

Customer acknowledges that they are prohibited from moving any unit that may cause disruption in service or damage. If unit needs moved, customer must contact Johnny Blue Inc., DBA as Executive Bathrooms Plus LLC.

Customer agrees to give final placement instructions one week prior to delivery. Level ground required, less than 5 percent grade. Johnny Blue Inc., DBA as Executive Bathrooms Plus LLC will not be responsible for property damage.

Should water need to be stored inside the utility closet, there is an additional charge to fill tank and utilize internal water pump.

All services rendered by Johnny Blue Inc., DBA as Executive Bathrooms Plus LLC will carry the appropriate sales tax. Tax exemption certificate must be provided to remove sales tax from invoice.

Customer acknowledges the Johnny Blue Inc., DBA as Executive Bathrooms Plus LLC will be affected negatively by any cancellation. All deposits are non-refundable. Customer may also incur a restocking fee and cancellation fee, if not cancelled 7 days prior to delivery.

Customer agrees to insure the portable sanitation facility against any risk of loss, theft or damage beyond reasonable wear and tear in the amount of their Actual Cash Value.

This entire agreement is between the customer and Johnny Blue Inc., also trading as Executive Bathrooms Plus LLC, and it may be modified only by a written agreement. The laws of the Commonwealth of Virginia shall apply to the interpretation and enforcement of this agreement, and any action or dispute hereunder shall be brought only in the courts of Virginia.

Unless otherwise agreed in writing, the maximum rental is 5 days.
